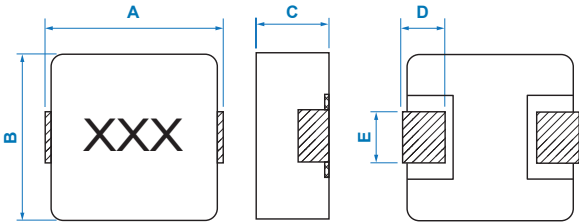

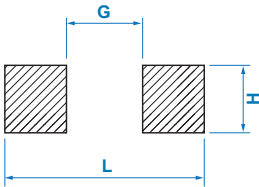

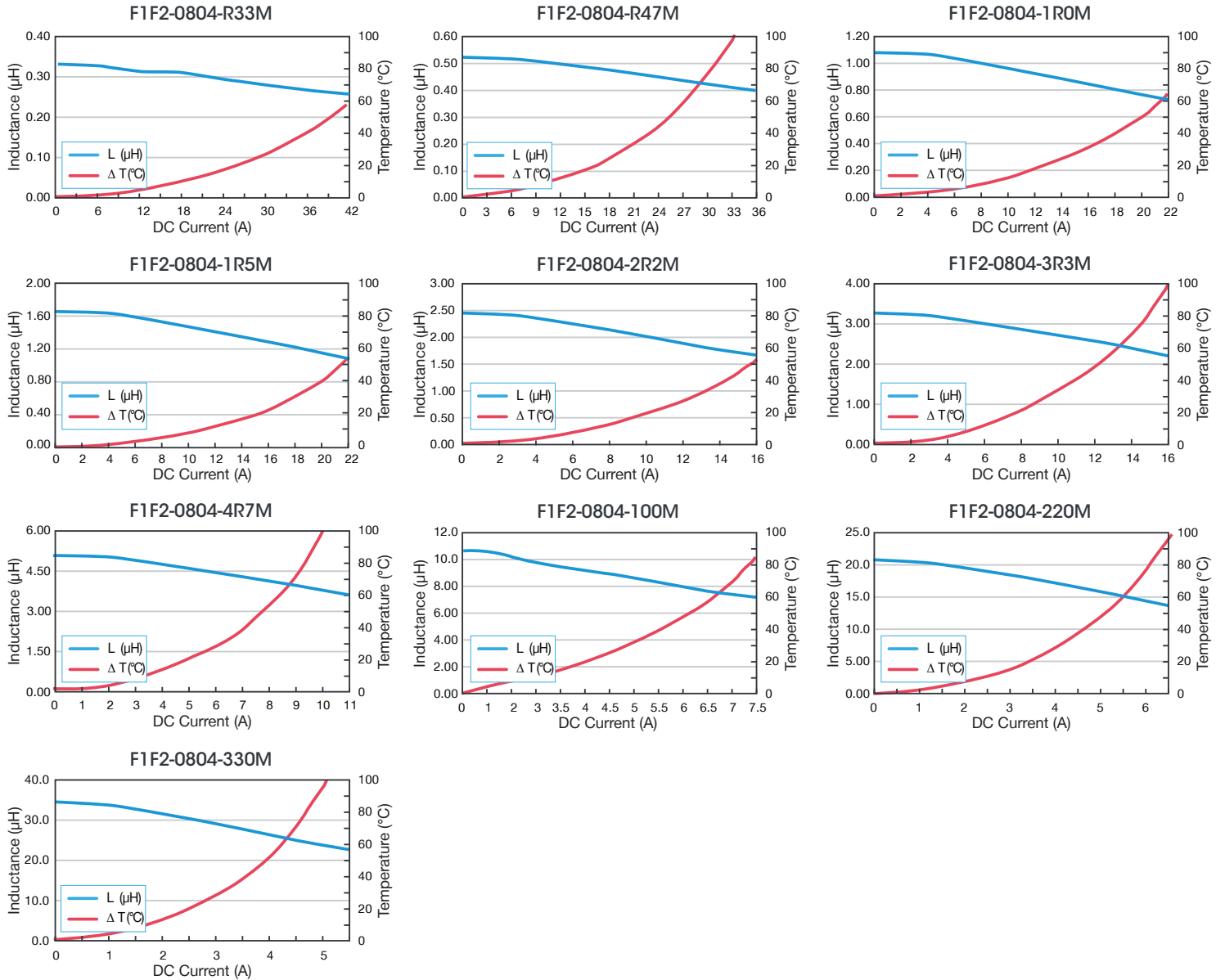


PAD LAYOUT

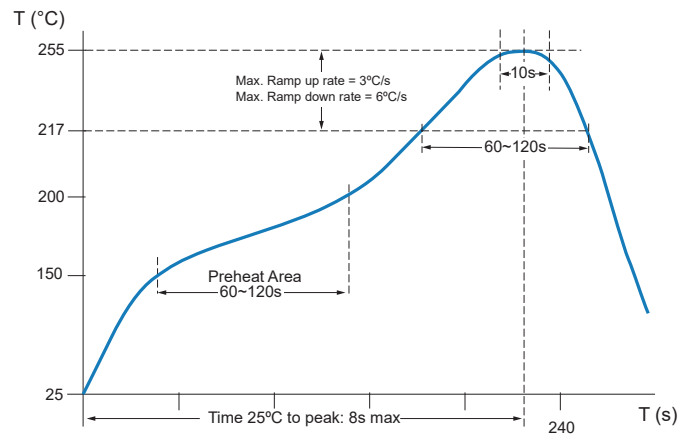

PERFORMANCE CURVES



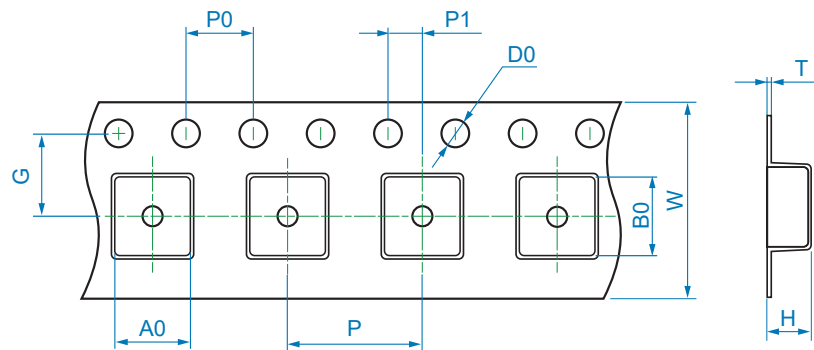
REFLOW SOLDERING TEMPERATURE CURVE

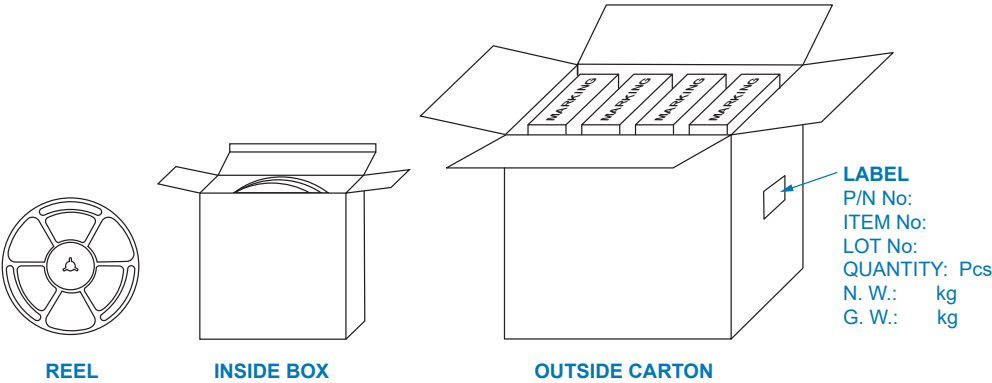


Peel-off Force
